PROFESSIONAL PHOTOGRAPHY AGREEMENT FOR WEDDING PHOTOGRAPHY COVERAGE IN 2009

This agreement, entered into on _____ is between Richard & Christine McGarry licensed in the State of New Hampshire and Massachusetts and doing business as Reflections by McGarry (hereinafter RBM) and the undersigned (hereinafter "Client") relating to the wedding of _____ that will take place at _____ on _____.

SERVICE COVERAGE: Package chosen: _____

The parties agree that RBM will furnish the services of _____ professional photographers, _____, and depending on the package, a third professional photographer acting as their assistant for photographic event coverage beginning at _____ until the conclusion of the event or for a maximum period of 8 (eight) hours, whichever is less. RBM will be the sole professional still photographer employed for the wedding day. Simultaneous photographic coverage by another professional photographer (excluding video) releases RBM from this agreement and immediately terminates service coverage. The time that extends past the 8 hours will be billed on an hourly rate of \$150.00 per photographer.

PAYMENT POLICY and EXPENSES: A retainer fee of 50% is paid to reserve event coverage for the service coverage specified above. A remaining fee, (plus any applicable sales taxes, will be paid by Client) at least 7 days prior to the wedding, plus reimbursement (only if applicable), air fare, hotel and transfer expenses incurred by RBM in performing the photographic duties expressed herein. **The retainer fee \$_____ is non-refundable.** This fee will be applied toward purchase of our wedding services or packages. Non-payment of any fees and/or reimbursements as described above releases RBM from any and all obligations defined in this agreement.

PRODUCT PRICING: Albums are priced at \$45 per page. Additional image prints will be made available online for purchase. RBM warrants that all prices quoted for professional services, photographs and albums are valid for a period of three months following the date of the wedding. Orders placed after this period will be billed at the studio's current pricing, which may be greater. **(A discount of 20% off additional album pages will be offered to all album designs approved and signed off within 4 weeks of viewing of the proposed initial design and proof images.)**

LIMITATION OF LIABILITY: While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding events, RBM's entire liability to Client for any claim, loss, or injury arising from the photographer's performance is limited to a refund to Client of fees paid. Because this is an uncontrolled event, RBM cannot guarantee delivery of any specifically requested image(s). In the unlikely event of personal illness or other circumstances beyond the control of RBM, a substitute photographer of high qualifications may be dispatched by RBM to fulfill the obligations of photography herein contracted.

REVIEW AND SELECTION: Original images of the wedding are the property of RBM. Images will be presented to the client for viewing usually within 4-6 weeks after the event. These images are protected by Federal Copyright Laws (see below).

ALBUM ORDERS: Using proprietary computerized design software, RBM will propose and advise in the layout of album(s), however, all choices by the client prevail. Album orders will include choice of photographs selected (with special instructions, if any) and these decisions are made following inspection of images. A total of three in-studio album design sessions are included with the package fee.

Additional album design sessions are billed an additional computer design fee of \$350 per session. To begin construction of the album(s) (that is not purchased as part of a package) a deposit of half of the remaining balance is required, with the balance due upon completion. Due to the custom nature of album orders, all orders are final upon submission of the deposit and cannot be changed under any circumstances.

DELIVERY: Following notification of completion of order, unpaid balances will be subject to a 1.5% monthly service charge. We are not responsible for albums left unclaimed after 30 days. Shipment of RBM's hand-assembled albums is ordinarily made within 2 to 4 months after receipt of the order.

FEDERAL COPYRIGHT LAWS: RBM owns all copyrights for any and all images produced in connection with this agreement, including the exclusive right to reproduce or publicly display such images.

OWNERSHIP OF IMAGES: Any reproduction of any image produced in connection with this agreement is prohibited without specific written consent of RBM. The parties agree that RBM may reproduce, publish or exhibit a judicious selection of such photographs as samples of photographic work to be shown to prospective clients, and for instructional or institutional purposes consistent with the highest standards of taste and judgment. Client agrees to hold RBM harmless against any and all claims arising from published images.

There are a total of two (2) pages to this agreement. **Please initial each page.** This is the agreement in full and cannot be amended by any party. This agreement is made, and, in all respects, is to be construed under the laws of the State of Massachusetts and of the United States. The parties agree that any dispute under this agreement will be adjudicated in a State or Federal Court located in Boston, Massachusetts and expressly agree to personal jurisdiction of such court.
